The Community Action Group (CAG) representative reported on the latest figures of gravel and sand extraction. He said that this proposed site was put forward in 2012 – 2008 and was rejected by NCC on the grounds that at that time Tarmac did not own the mineral rights and it was felt that they could not deliver the project within the five year plan. After further discussion it was agreed that the Parish Council would send a response and identify our objections on the proposed scoping plan it was agreed that Cllr Ian Brady and Cllr John Allan with the Clerk would prepare the response paper.
